Objectives of the Consultancy

The objective of this consultancy is to provide support to the Ministry of Agriculture, Animal Husbandry and Fisheries (LVV) Agriculture Statistics Department (DAS) to coordinate the activities for the conduct of the 6th Agriculture census in collaboration with the Food and Agriculture Organization of the United Nations (FAO) and the Project Execution Unit (PEU). The Consultancy will be executed on a full-time basis for an initial period of one year with expected start date of January 2023.

The Ministry of Agriculture, Animal Husbandry and Fisheries (LVV), through the Inter-American Institute for Cooperation on Agriculture (IICA) now invites eligible individuals ("Consultants") to indicate their interest in providing the services.

Qualification:

Minimum of Bachelor 's degree in Public Sector Management, Business Administration, Project Management or a field related to the assignment.

Experience and Competencies:

- At least 5 years' experience working in administration functions in public/ private sector at middle management level;
- At least 3 years' experience in project planning and coordination;
- At least 3 years' experience in the preparation of budgets and work plans;
- At least 1 year experience in working with multiple stakeholders including an international organization
