**Abstract:** The call for expressions of interest has the explicit purpose of compiling a prequalification list of Individual Consultant as Monitoring and Evaluation Coordinator- Office of the Minister of Agriculture, Animal Husbandry and Fisheries.

The Government of Suriname has received financing from the Inter-American Development Bank (IDB), toward the cost of the Agricultural Competitiveness Program and intends to apply part of the proceeds for consulting services.

**Objectives of the Consultancy**

The objectives of this consultancy are: (1) to support the management of the Ministry of Agriculture, Animal Husbandry and Fisheries in the monitoring, evaluation, and timely execution of the Agriculture Sector projects; (2) to provide direct support to the Office of the Minister of Agriculture in decision-making and timely responses to project requests as part of an internal integrated change control process. This consultancy is expected to commence in August 2022 for a period of 1 year on a full-time basis, in the first instance.

The Ministry of Agriculture, Animal Husbandry and Fisheries (LVV), through the Inter-American Institute for Cooperation on Agriculture (IICA) now invites eligible individuals (“Consultants”) to indicate their interest in providing the services.

**Qualification**

**Minimum mandatory requirements \*(Required)**

- 1) **Qualification:** At least a Master’s degree in one of the following: Public Administration, Public Policy, Business Administration, Executive Management Degree (MBA), Project Management or a field related to the assignment.
- 2) **General Experience:** at least five (5) years’ experience working in the public or private sector, or with international organizations, in roles and with functions related to this assignment.

**\*If these minimum requirements are not met, the candidates will not be considered for the process\***

**Specific Experience**

- At least three (3) years’ practical experience in Strategic Management at middle management level or higher

- At least five (5) years' experience in monitoring sectorial programmes or projects
- At least two (2) years' experience with change management methodology and application
- At least 2 years' experience in coaching of groups (10 or more persons).

**Interested Consultants should provide information demonstrating that they have the required managerial and technical capabilities, qualifications and relevant experiences to perform the Services.**
