This international bidding notice was announced under the General Procurement notice advertised for this project published in Development Business Online, edition No. IDB-P444353-12/19 of December 16, 2019.

The **Republic of Suriname** has received financing from *the Inter-American Development Bank (IDB)*, and it intends to apply part of the proceeds to payments under the project **Health Services Improvement Project**, for the purchase of “**Purchase of medical supplies for Chronic Care Start-Up**”.

The **Ministry of Health** now invites sealed bids from eligible bidders for the provision of “**Purchase of medical supplies for Chronic Care Start-Up**”. *This procurement process requires bidders to have the following specific experience and/or capabilities: (For guidance use Section III – Evaluation and Qualification Criteria of the Bidding document).* The delivery period is between 8 and 10 weeks. The requirements and qualifications are included in the bidding documents.

Bidding will be conducted through International Competitive Bidding procedures as specified in the Inter-American Development Bank’s *Policies for Procurement of Works and Goods financed by the Inter-American Development Bank (GN-2349-15)*, and is open to all eligible bidders as defined in the policies. *The contracts will be financed out of the loan of the Inter-American Development Bank which will further restrict eligibility.*
