This international bidding notice was announced under the General Procurement notice advertised for this project published in Development Business Online, edition No. IDB-P444353-12/19 of December 16, 2019.

The **Republic of Suriname** has received financing from *the Inter-American Development Bank (IDB)*, and it intends to apply part of the proceeds to payments under the project **Health Services Improvement Project,** for the purchase of **"Purchase of clinical equipment for the upgrading of 4 Chronic Care Models centers".**

The **Ministry of Health** now invites sealed bids from eligible bidders for the provision of "**Purchase of clinical equipment for the upgrading of 4 Chronic Care Models centers**". *This procurement process requires bidders to have the following specific experience and/or capabilities: (For guidance use Section III – Evaluation and Qualification Criteria of the Bidding document)*. The delivery period is between 8 and 10 weeks. The requirements and qualifications are included in the bidding documents.

Bidding will be conducted through International Competitive Bidding procedures as specified in the Inter-American Development Bank's <u>Policies for Procurement of Works and Goods financed by the Inter-</u> <u>American Development Bank</u> (GN-2349-15), and is open to all eligible bidders as defined in the policies. The contracts will be financed out of the loan of the **Inter-American Development Bank** which will further restrict eligibility.
