1. This Invitation for Bids follows the General Procurement Notice for this Project that appeared in *Development Business*, issue no. *IDB-P791068-07/21* of 29 July 2021.
2. The *Government of the Republic of Suriname* has received financing from the Inter-American Development Bank toward the cost of Sustainable Agricultural Productivity, and it intends to apply part of the proceeds of this financing to payments under the Contract for *Procurement of 28 motorcycles for the Census Unit of the Ministry of LVV and 3 motorbikes for the Water Masters; IDB-1052-LVV/G-2023/NCB-006*.
3. The *Ministry of Agriculture, Animal Husbandry and Fisheries* now invites sealed bids from eligible and qualified bidders for *Procurement 31 motorcycles (50-80cc, Manual transmission Kick & Electric) for the Ministry of LVV*.
4. The Request for Bids will be conducted through the National Competitive Bidding (NCB) procedures specified in the Inter-American Development Bank's Policies for the Procurement of Works and Goods financed by the Inter-American Development Bank, and is open to all bidders from Eligible Source Countries as defined in the Policies.

6. Qualifications requirements include: *technical (as listed in Schedule of Requirements section VI of Bidding Document) financial, legal and other requirements*. A margin of preference for certain goods manufactured domestically *shall not* be applied. Additional details are provided in the Bidding Documents.
