1. This RFB follows the General Procurement Notice for this Project that appeared in *Development Business*, issue no. IDB-P791068-07/21 of 29 July 2021.
2. The *Government of the Republic Suriname* has received a loan from the Inter-American Development Bank toward the cost of *Sustainable Agriculture Productivity Program*, and it intends to apply part of the proceeds of this loan to payments under the Contract for ***Rehabilitation works on irrigation and drainage systems of the Water Board WaSima; IDB-1052-LVV/G-2023/NCB-007 (SAPP-74-LPN-O-1.2.3)***
3. The ***Ministry of Agriculture, Animal Husbandry and Fisheries (LVV)*** now invites sealed bids from eligible and qualified bidders for ***IDB-1052-LVV/G-2023/NCB-007 (SAPP-74-LPN-O-1.2.3) Rehabilitation works on irrigation and drainage systems of the Water Board Wasima which includes cleaning/deepening of canals, reconditioning roads and reconstruction of intake works.*** The Intended Completion Date is ***six (6) months after commencement date.***
4. The RFB will be conducted through the National Competitive Bidding (NCB) procedures specified in the Inter-American Development Bank's *Policies for the Procurement of Goods and Works financed by the Inter-American Development Bank GN-2349-15 approved by the Board of Executive Directors of the Bank on 2<sup>nd</sup> of July 2019 and effective 1<sup>st</sup> of January 2020*, and is open to all bidders from Eligible Source Countries as defined in the bidding document.
5. Interested eligible bidders may obtain further information from ***Ministry of Agriculture, Animal Husbandry and Fisheries (LVV) to the attention of Ms. Geraldine St. Croix (Project Manager of the PEU)*** and inspect the bidding document at the address given below.
