The Government of Suriname has received financing from the Islamic Development Bank towards the costs of the AFFORDABLE HOUSING PROJECT (AHP), and intends to apply part of the proceeds of this financing to eligible payments under the contract of consultant services of an Individual Consultant for which this Expression of Interest is issued.

## Background

To improve the living conditions of low-income households and to enable the target groups to provide in their need of adequate housing, the Government of Suriname has established the Affordable Housing Project (AHP) with a loan from the Islamic Development Bank (IsDB). Affordable housing is a vital instrument in the Government Social Safety Net Program, as it provides social and economic security for the people.

The amount of the agreement is thirty-five million US Dollars (US\$ 35,000,000) and the Program started in 2019. The general development objective of this program is to significantly improve the living conditions of low and lower-middle income population by providing access to affordable and improved quality of housing. Providing sustainable housing solutions is an important policy anchor of the Santohki-Brunswijk Administration.

The key development results of the project are as follows: Main Outputs:

- 3,775 affordable and decent housing will be constructed, renovated or improved, of which 40% of the beneficiaries will be women (women-headed families/ households);
- 1,675 new housing units will be built in the hinterland and urban (with and without land);
   2100 housing units in the hinterland and urban will be renovated or improved.

In order to achieve these results, the MOSAPH is selecting a suitable professional to support the implementation of this Program. These positions are:
