This international bidding notice was announced under the General Procurement notice advertised for this project published in Development Business Online, edition No. IDB-P2134876-08/24 of 26 August, 2024.

The Government of Suriname has received financing from the Inter-American Development Bank (IDB), and it intends to apply part of the proceeds to payments under the project *Fiscal Support Program to Regain Growth (FISREG)*, for **Supply and Delivery of new pick-ups for the Directorate of Taxes and Customs (DoTC), SU-L1060-P00056-FISREG-G-ICB-001**.

The Program Implementation Unit (PIU) FISREG of the Ministry of Finance and Planning now invites sealed bids from eligible bidders for the “*Supply and Delivery of eleven (11) new pick-ups for the Directorate of Taxes and Customs (DoTC)*”.

Bidding will be conducted through international competitive bidding procedures as specified in the Inter-American Development Bank’s *Policies for Procurement of Goods and Works financed by the Inter-American Development Bank* (GN-2349-15), and is open to all eligible bidders as defined in the policies.
