### **Suriname Competitiveness and Sector Diversification Project (SCSD)**

#### **1. Background**

The Government of Suriname has received a loan from the World Bank to fund the **Suriname Competitiveness and Sector Diversification (SCSD) Project**. The project's objective is to support private sector investment and competitiveness in key industries, including mining, agribusiness, and tourism.

Project activities are managed by Project Implementation Units (PIUs) within the Ministry of Natural Resources (MNR) and the Ministry of Economic Affairs, Entrepreneurship and Technological Innovation.

#### **2. Request for Information**

The project is conducting market research for two upcoming legal consultancies to gather information for a formal bidding process. We invite qualified individual consultants and firms to express their interest by providing relevant information and documentation. Max 6 pages.

**Objective:** To strengthen the legal and institutional framework for business and professional licensing in Suriname.

### Main Tasks:

- Design and implement a methodology to identify licensed and unlicensed business types.
- Advise on legal products that do not require parliamentary intervention.
- Draft a state decree for Economic Zoning.
- Conduct a comprehensive inventory of activities that require a business license.
- Draft new legislation and identify two additional "low-hanging fruits" to strengthen the legal framework.
- Facilitate consultations with relevant ministries, chambers, and sector associations.
- Support the preparation of documentation for legislative review and approval.

### Legal Consultant – Secured Transactions Reform

**Objective:** To strengthen the legal and institutional framework for secured transactions to enhance legal certainty and access to credit for businesses.

### Main Tasks:

- Conduct a legal gap analysis between the current secured transactions framework and the New Civil Code (NBW).
- Draft amendments or new legislation to ensure legal consistency and enforceability.
- Propose institutional reforms related to registration, enforcement, and dispute resolution.

- Organize consultations with legal experts, financial institutions, and government stakeholders.
- Prepare documentation for parliamentary review and legislative approval.
