1. This Invitation for Bids is issued following the publication of the General Procurement Notice (GPN) for this project, which was published on the Inter-American Development Bank's website under publication number **IDB-P791068-07/21** on **29 July 2021**.
2. Suriname has received financing from the Inter-American Development Bank (IDB) to partially finance the cost of the **Sustainable Agricultural Productivity Program** and intends to apply part of the proceeds to payments under the Contract detailed in this Request for Bids.
3. **The Ministry of Agriculture, Animal Husbandry and Fisheries** invites eligible bidders to submit sealed bids for **Rehabilitation of unpaved road (Coromandal Weg) located at Waterboard Nanni-& Brutopolder in Nickerie District, Suriname**. The total length of the road section is **5,420 meters**; with a right-of-way width of **7.0 meters** and a carriageway width of **5.0 meters**. The geographical coordinates of the location are starting point: **5°52'48.8"N 57°01'46.6"W** to end point: **5°52'54.7"N 57°04'39.4"W**. The estimated construction period is **2 Months**.
4. The Request for Bids (RFB) will be conducted through the **National Competitive Bidding** process as specified in the Inter-American Development Bank's Procurement Policies for the Procurement of Goods and Works (applicable edition according to the Loan Contract). The process is open to all bidders from eligible countries, as defined in the Bidding Documents.
5. Bidders must meet the following qualification criteria: Qualification requirements include key technical, financial, legal, and other requirements.
