Background

In February 2026, the Republic of Suriname has issued a Social Bond to finance eligible social expenditures and priority social projects. The Ministry of Finance and Planning (Employer), for the benefit of the Academic Hospital Paramaribo, now invites sealed bids from eligible bidders for the supply, delivery and installation of Medical Equipment and Furniture.

Scope of Supply (Lots)

Supply, delivery, and installation of Medical & Equipment as specified in Section VI – Schedule of Requirements of the bidding document. Lots include:

- Lot 1: **Critical Care and life-support**
- Lot 2: **Clinical Support Equipment**
- Lot 3: **Hospital Furniture**

Suppliers must also provide configuration, installation, and warranty services as per the technical specifications.

Procurement Method

Bidding will be conducted through **International Competitive Bidding (ICB)** procedures, in accordance with internationally recognized procurement practices and Suriname's Social Projects Procurement Framework (Feb 2026).

Eligibility

Participation is open to all firms that demonstrate (in accordance with the Bidding Document):

- Legal eligibility (no sanctions, conflicts of interest)
- Financial capacity
- Technical capacity

Bid Evaluation

Evaluation will be based on the lowest evaluated responsive bid, considering:

- Technical compliance with specifications
- Delivery and installation schedule
- Price and commercial terms
- Warranty and service commitments

- Bids will be opened publicly at **11:05 a.m. local time on the same day**, in the presence of bidders' representatives who choose to attend.
